# RULES

All classes need a minimum of 3 entries in order to race. **Ages as of May 1, 2010**  
**PeeWee Bike** – 0-50cc 2-Stroke/4-Stroke, 10 years & younger.  
**Jr Bike** - 65cc 2-Stroke, 110cc 4-Stroke  
**Sr Bike** – 0-90cc 2-Stroke, 0-150cc 4-Stroke.  
**C Quad**- No A, B or Open Class quads allowed. Full sized chassis.  
**Stock 60cc Quad** - No factory performance machines allowed. 100% factory stock machines, no modifications of any type allowed. Tires and rims must be stock type (no wheel spacers, offset wheels, or flat-track tires). Air box must be stock & complete. This class is for beginner riders age 10 & younger.  
**Stock 90cc A Quads** – 80-90cc quads, visually stock. Extremes, tire modifications, rims & spacers Allowed. Must have stock exhaust. No Spark Arrester. Air box lid not required. No 50-60cc quads allowed to race. 13 years & younger.  
**Stock 90cc B Quads** – 80-90cc quads, visually stock. Extremes allowed. Tires and rims must be stock type (no wheel spacers, offset wheels, or flat-track tires). Must have complete exhaust, spark arrester & drain plug. Electric start MUST work.  
**Super Stock** – Must have original motor & chassis. 0-90cc 2-Stroke, 0-125cc 4-Stroke. 13 yrs & younger.  
**Open Mini Quad** – 0-90cc 2 Stroke 0-125cc 4 Stroke. Anything goes, this is an advanced rider class. 8-13 years old.  
**Jr. Quad** – 0-200cc 2 Stroke / 0- 300cc 4 Stroke (minimum chassis size Blaster) 15yrs. or younger

## Voluntary Release – Assumption of Risk & Indemnity Agreement

The undersigned person requests and is granted permission (1) to enter the RESTRICTED AREA, (2) to participate as driver, crew or assistant in a racing event, (3) to compete for money, prizes, recognition or reward, (4) to be covered by participant's Hospitalization insurance as limited by the master insurance policy (all collectively herein called "permissive entry"). In consideration of 'permissive entry' to the restricted area, which is the area to which the admission of the general public is prohibited, which includes but is not limited to the pit area, racing surface, infield adjacent sidewalks, concessions and other appurtenances. I the undersigned for myself, my personal representatives, heirs, next of kin, spouse & assigned, DO HEREBY:

1. RELEASE, DISCHARGE & COVENANT NOT TO SUE the track operators, track owners, land owners, racing association, & each of them, their officers, agents & employees (all herein after collectively referred to as 'releases') from any and all claims & liability arising out of strict liability or ordinary negligence of releases or any other participants uses the undersigned injury, death, damages, or property damage. I hereby covenant to hold releases harmless & indemnity releases for any claim judgment or expense releases may occur arising out of my activities or presence in the restricted area.
2. UNDERSTAND that my entry into the restricted area and/or participation in racing events contains DANGER & RISK OF INJURY OR DEATH, that conditions or the racing surface change from time to time and may become more hazardous, and that there is INHERENT DANGER in racing which I appreciate & voluntarily assume, because I choose so to do. I have observed many races of the type that seek to participate in, I have inspected the racing surface, access roads, shoulders, equipment, barriers or lack thereof, lighting or lack thereof, and the weather conditions. I further know that other contestants & participants pose a danger to me, nevertheless, I VOLUNTARILY ELECT TO ACCEPT ALL RISKS connected with my entry into the restricted area and/or participation in any racing events.
3. ACKNOWLEDGE that I am aware of all track & equipment safety regulations & I have complied with each regulation, if I have failed to do so, I ASSUME ALL RISK for myself & assume all liability to others for such failure, & I hereby RELEASE releases for any failure to inspect my vehicle or others. I am not an agent, servant or employee or release & no oral representations of inducements have been made to me if I sign this agreement. If any portion of this agreement is held invalid, it is agreed that the balance thereof shall continue to be in full legal force & effect.
4. AGREE that this agreement shall apply to any incident, injury, accident, or death occurring at the captioned track on the below date & for a period of one (1) YEAR after the execution of this agreement. I HAVE READ THIS DOCUMENT. I UNDERSTAND IT IS A RELEASE OF ALL CLAIMS. I UNDERSTAND & ASSUME ALL RISKS INHERENT IN RACING.

I VOLUNTARILY SIGN MY NAME EVIDENCING MY ACCEPTANCE OF THE ABOVE PROVISIONS.
